 - Thirteen indicators serve as a foundation for consistent delivery of quality chapters across the nation
 - Focuses on the operations of a quality chapter at the local level
 - National Quality Program Standards for Agriculture, Food and Natural Resource Education (NQPS) are closely linked to NQCS

A minimum of 51 points or higher in addition to the activity summaries must be earned and completed in order for a chapter to fill out Form II. If the dates in any activity do not coincide with the dates listed on the cover of the application, a 25 point deduction per activity will be assessed.
